### ***Special Presentation***

**Lt. Col. Theodore "Ted" Tanner, USAF (Ret.)**



In his moving "Combat Flying in the South Pacific Theater during World War II" presentation **Lt. Colonel Tanner** shared his vast World War II flight experiences with Freedom Committee of Orange County members. He also shared his extensive Flight Training history in both single and multi-engine aircraft.



The single engine P-40 Fighter was his first assigned aircraft he flew in the Pacific Theater. He later flew the multi-engine A-20 twin engine light bomber. He flew 72 missions in the New Guinea Theater, with his U.S. Army Air Forces unit losing 50-60 personnel during the war in the process.



Some of his fellow pilots with whom he trained in 1943 went on to fly and die in the new B-29 Superfortress Strategic Bombers.

Many of his unit's outstanding war missions are vividly shared in The Eagles Over The Pacific, Volume 3 book titled "Rampage of the Roarin' 20's" - The Illustrated History of the 312th Bombardment Group During World II' written by Lawrence J. Hickey, Michael H. Levy and Michael J. Claringbould.

He conducted an outstanding Power Point Display accompanying his presentation for Freedom Committee members to share. This was a great and detailed program by a real combat pilot who flew in the South Pacific Theater against the Japanese. Lt. Col.
