***“Combat Medics-Going Where the Action Is”***



**Frank Ramirez** shared with the FCOC members his Korean War time experiences. We know North Korean People's Army, KPA, invaded South Korean Republic of Korea, ROK, on June 25, 1950 with a Pearl Harbor-type surprise attack. Lightly armed American and ROK troops were swept aside. The South Korean capital of Seoul was captured in three days. The KPA communist soldiers continued attacking south and a month later all that was left of South Korea was a 50 mile radius around the port city of Pusan. The 23<sup>rd</sup> Combat Regimental Team was the first American soldiers from the US mainland to land in Korea. They were also the 1<sup>st</sup> to break out of the Pusan perimeter and chase the Communist troops back north.



**Frank Ramirez** was a local Orange County man that was drafted and trained as a combat rifleman. Arriving in Korea in the summer of 1951, Frank was assigned to the 2<sup>nd</sup> Infantry Division. The fighting arm of the 2<sup>nd</sup> ID was three infantry regiments; the 23<sup>rd</sup> Regimental Combat Team was the one **PVT Ramirez** was assigned to. There were three battalions in the 23<sup>rd</sup> RCT. While waiting assignment to his battalion, Frank and five other men were called out and told to exchange their rifles for medical kits. They were Army Medics now. (The Navy and Marines refers to them as Corpsmen). After one day training, Frank was assigned to E Company, 2<sup>nd</sup> Battalion. During this training, they were informed that they were “Immuned from Fear”.

In September 1951, The U.S. 2nd Infantry Division seriously underestimated the strength of the North Koreans' dug-in positions along seven mile long hill mass just north of the 38<sup>th</sup> parallel. They ordered a single infantry regiment (the 23<sup>rd</sup> RCT) and its attached French battalion to make what would prove to be an ill-conceived assault with straight up heavily fortified slopes. The fighting was savage; no mercy was given or asked by either side. The ridgeline (called **Heartbreak Ridge** by the American Infantrymen) changed hands many times in an exhausting series of attacks and counterattacks. "Combat Medics: going where the action is", Frank's medic job was to follow closely the combat troops and treat the wounded. During a retreat, Frank would evacuate the wounded off the battlefield, sometimes unassisted by the retreating infantrymen. **PFC Frank Ramirez was awarded a Silver Star Medal for heroism for his actions** on September 24, 1951.



During a retreat, several wounded were left behind. Frank, armed with a Red Cross on his helmet and carrying a medical bag, went back up the hill and brought them back to safety. Frank also wears the Combat Medic Badge.



During the Korean War, 830 Army Medical Servicemen were killed and 3,270 wounded. Navy Hospital Corps suffered 108 killed. Frank was wounded by a ChiCom mortar and wears a **Purple Heart Medal**. In Korea, the hospital death rate for wounded GI's was, up to then, the lowest in the history of Warfare due in part to the bravery and expertise of men called "Doc". **Freedom is not Free!**

A short film was shown, "Corpsman Up!"

Ted asked that all FCOC members be on the lookout for any of Frank's items being sold at swap meets. He also recommended that everyone video tape their homes and belongings to aid the Police in identifying the items if they are stolen.
